BARK CENTRAL DOG PARK MEMBERSHIP APPLICATION

Contract Regulations

By signing this contract you, the Buyer(s), have purchased for your dog(s) a membership to Bark Central Dog Park. Buyer(s) agree that the membership fee is non-refundable unless Bark Central Dog Park is no longer able to provide a substantial number of the services offered when this contract was signed, in which case Buyer(s) will receive a prorated refund.

Buyer(s) agree that the membership is not transferable to another dog owner. Other dogs owned by the Buyer(s) may be substituted for those named on the application provided they are approved by the park management.

Additional dogs owned by the Buyer(s) may be added to those named above provided the dogs are approved by the park management and the difference in membership rate is paid.

Buyer(s) may cancel this contract without penalty and receive membership refund (minus initiation fee) within 7 calendar days of the date membership begins. Bark Central Dog Park reserves the right to deny entry to the facility or membership in the facility for any reason, and to terminate membership or expel a person and/or dog from the facility for any reason. If Bark Central Dog Park terminates a membership, the corporation reserves the right to return pro-rated fees or no fees.

Indemnity Agreement, Release and Waiver of Liability and Assumption of Risk

Bark Central Dog Park has created a park for dogs and their owners and guests to enjoy together. I understand that the use of this park and other Bark Central Dog Park facilities means that I am taking certain risks of injury to myself, my guests, my dog and my property. I realize that when dogs are around strange people and other dogs, some accidents or injuries may result, and that dogs, people, and property might be injured or damaged.

Because I want to use and enjoy Bark Central Dog Park and its facilities, I hereby agree to assume these risks for myself, my guests, my dogs and my property. I agree that it is solely my responsibility to determine whether Bark Central Dog Park property itself and any particular situation involving other members, guests and dogs is safe for myself, my guests, my dogs and my property.

In exchange for the opportunity to use Bark Central Dog Park, I hereby release and discharge Bark Central Dog Park and its officers, directors, shareholders, property landlord or appointees or representative and employees from any and all liability, claims, demands, causes of action, loss damage or injury to person or property, including any death or serious injury which may result while I or my guests or my dogs are at Bark Central Dog Park. I also agree to be responsible for my guests and my dogs and for any liability caused by me, my guests and my dogs.

I further agree to hold harmless and indemnify Bark Central Dog Park for any claims, causes of action, or lawsuits asserted against Bark Central Dog Park or its officers, directors, members, and employees that are asserted because of any action or inaction of me, my guests, or my dogs. This indemnification shall include the costs of actual attorney fees and costs.

I have read, understand, and agree to abide by all of the Contract Regulations, Bark Central Dog Park Rules, and the Indemnity Agreement, Release and Waiver of Liability and Assumption of Risk. I understand that Bark Central Dog Park management reserves the right to alter or amend its rules at any time. I intend for this release to be binding upon my heirs, beneficiaries, next of kin, personal representative or executor and assignees.



BARK CENTRAL DOG PARK RULES AND REGULATIONS

- Watch your dog and keep him or her within your command at all times, keeping your dog's leash with you.
- Dogs must be on leash entering/leaving the park. When in the off-leash areas, they must be off-leash, except in the case when you must correct or evacuate the dog. Leashes must be with you AT ALL TIMES.
- No bullies! Rough play is fine as long as it is consensual. Rough play and chasing are not acceptable if any of the dogs involved or owners are not comfortable with the situation.
- Dogs must be current on all vaccinations for entry.
- Dog Feces: Owners are responsible for cleaning up after their dogs.
- Do not let anyone other than you guests and paid-for dog guests through the member gate at any time, regardless of what they tell you. Direct them to our office. Make sure you close the member gate after you, even if people are waiting to go through the gate.
- Non-Member Dogs: Members may bring non-member dogs with them only during the hours the Park office is open, and upon paying the visitor's fee. A visitor dog may not be brought into the off-leash park during any other times unless prior arrangements with management have been made. Members may bring people guests with them at any time.
- Digging: Do not let your dog dig holes. Digging is allowed only in the doggie digging area.
- Barking: If your dog is barking excessively, you will be asked to leave the park.
- Children: Children under age 14 are not allowed in the park. Children under 18 must be within direct adult supervision everywhere while on park property and are never to be further than 10 feet from an adult. Children must follow all rules and not be allowed to destroy any property, including pulling on, standing on, leaning on any fence, park equipment, dog training equipment or any other assets of Bark Central Dog Park.
- Male dogs over seven months of age must be neutered to enter the park. Some exceptions may be made by management.
- Food: Nothing edible for dogs or people is allowed in the off-leash areas of the park. Human drinks are permitted.
- If aggressive behavior is observed, take immediate action: move your dog to another area or leave the park. Please report incidents to management.
- Dog fights: To avoid a dog fight, I agree that I can control and command my dog while in the park and I will keep watch over my dog while in the park to insure it is not exhibiting aggressive or antagonistic behavior. I further agree that I will do everything possible to remove my dog from situations uncomfortable to me, my dog, or other dogs or their owners. Further understand that under no circumstances should you ever grab a fighting dog by its collar or anywhere near the biting end of the dog, as you risk being bitten.



BARK CENTRAL DOG PARK RULES AND REGULATIONS

- Dogs in heat, dogs that are sick, and dogs with obvious external parasites or conditions (e.g. fleas, mange) are not permitted in the Park. Due to the outside nature of the Park, we strongly recommend flea and tick treatments at all times.
- Any and all dog training equipment can be used only under supervision of the trainer, except in the off-leash area. People, including children, can never sit, stand, jump over, or play on any dog training equipment.
- No more than 3 of your registered dogs in your household are allowed in the Park per visit.
- Membership dues are payable either monthly or annually. Monthly dues are payable by the first of each month.
- Report lost or stolen access keys to management immediately. You are responsible for any unauthorized person accessing the park using your key.
- Please respect the privacy of our neighbors.
